## **800. ST ANN'S CHURCHYARD**

It was resolved that the tender submitted by M Wright Gardening be accepted. It was resolved that the contract will commence on 1<sup>st</sup> April 2010 and will be subject to a 3-month probationary period.

It was resolved that notice be sent to the existing contractor to terminate his contract at 31<sup>st</sup> March 2010.

## **801. HONOURS BOARDS**

It was resolved that the Clerk finds time to continue research into past chairmen of the Council before a decision is made about the starting year for the Honours Board.

## **802. WAR MEMORIAL**

It was resolved that Simon Roger Owen, who died while serving in the Gulf, be added to the servicemen listed on the Rainhill War Memorial.

## **803. WHISTON CROSS**

It was resolved that the pitch hire payments made by Whiston Cross will be deemed to be full settlement of all outstanding fees.

## **804. RAINHILL ROCKETS**

It was resolved that Rainhill Rockets will be contracted to take on Keyholder / Caretaker/ Cleaner responsibilities at Holt Pavilion in lieu of payment of pitch hire fees, the contract to start from 1<sup>st</sup> July 2010.

It was resolved that the existing, separate, Cleaner role will no longer be required after 30<sup>th</sup> June 2010.

#### **805. RAINHILL PARK AND HOLT PLAYING FIELDS**

It was resolved this item be carried forward to the next meeting on 29<sup>th</sup> March 2010 pending an anticipated response from Mr. B Johnson (St Helens Council) following the joint meeting on 18<sup>th</sup> February 2010.

#### **806. RAINHILL GALA**

It was resolved that a team from Rainhill High School will again be sponsored by the Parish Council to take part in the 2010 Rainhill Gala. This will include the entry fee, provision of T-shirts and light refreshments.

#### **807. PUBLIC TOILETS**

Cllr Grunewald advised that the proposed Museum / Café / Real Ale Bar at Rainhill Railway Station should include the public use of toilet facilities.

#### **808. RESIDENTS COMMENTS AND COMPLAINTS**

##### Rubbish overspill in Dane Court

It was resolved that the Clerk should write to both the Dane Court owners and the YMCA Charity Shop regarding the overspill of rubbish. Rubbish should either be kept inside shop premises until rubbish collection day or rubbish should be screened off.

##### Non-collection of green bins containing cardboard

This is a St Helens Council responsibility and Cllr Grunewald offered to try and resolve the problem.

- St. Helens South & West Crime Prevention Panel: Following an unsatisfactory reply to a letter sent on 6<sup>th</sup> June 2009, it was resolved that the Clerk send a similar letter to the Chair specifying Crime Prevention ‘Team’ instead of Crime Prevention ‘Panel’.
- Merseyside Association of Parish & Town Councils: Cllr Wood advised that the meeting planned for 3<sup>rd</sup> February was postponed and had not yet been re-arranged.

- Rainhill Ward Committee: Cllr Grunewald advised that the vehicle-activated speed signs were now operational. It was resolved that the Clerk include an Agenda item for the next meeting on 29<sup>th</sup> March 2010 to confirm what money is being provided by the Parish Council towards the cost of the signs.
