773. PLANNING APPLICATIONS

P/2010/0008 Rainhill Park – Children's Play Area

It was resolved that the Clerk sends an email to Mr Johnson confirming this application has the full support of the Council.

775. DRAFT BUDGET

It was resolved that the Clerk include calculations, showing the effect of various percentage increases in Precept on the Parish Council finances, in the budget report. It was resolved that discussion of the budget and setting of Precept be deferred until an extraordinary meeting of the Parish Council to take place as soon as possible.

776. GOOD CITIZENSHIP AWARDS

It was resolved that the Good Citizenship Awards evening should take place on Friday 26th February.

It was resolved that each recipient of an award may bring up to 3 guests with them.

It was resolved that all councillors will be invited to the Awards evening and that the clerk issues a RSVP invitation as soon as possible so that final numbers may be determined for the evening.

It was resolved that, if possible, the same caterer used in previous years will be asked to supply the buffet.

777. WARD COMMITTEE

It was resolved that the Ward Committee would take the lead in the next set of improvements to be made to the village Christmas decorations.

778. ST ANN'S CHURCHYARD

It was resolved that the Clerk should invite tenders for a new contract starting in April 2010.

779. HONOURS BOARDS

It was resolved that the Clerk should arrange for the purchase and installation of glass boards, similar to those used by Eccleston Parish Council, to record past Chairmen of the Parish Council.

780. WAR MEMORIAL

It was resolved that the Parish Council adopt the same policy used by St Helens Council in deciding whether an additional name may be added to the Rainhill War Memorial, i.e. the person being considered must have been born in Rainhill. If that criterion is not satisfied the request will always be refused. If the person being considered was born in Rainhill and died in conflict the request will be accepted; where the person died in any other circumstances, each case will be considered on an individual basis.

781. PUBLIC OPEN SPACES – RAINHILL UNITED AFC

It was resolved that the Clerk advises Rainhill United AFC that, although the Parish Council would like to support their initiatives to improve the pitches they use at Rainhill Park, it is not possible to grant them a lease of any length, as the Parish Council is not allowed to sub-let the land it leases from St Helens Council.

782. RAINHILL STATION

Correspondence received concerning the impact on Rainhill when the line electrification goes ahead was considered. It was resolved that no further action is required.

783. LETTERHEAD AND PRINTING

It was resolved that the Parish Council letterhead be changed using the template provided by Cllr Heydon.
